



# Terms and conditions membership of the Foundation The Chamber of Commerce The Netherlands & Turkey

## 1. What does the membership mean?

Membership is proprietary and provides access to products and services of the Foundation The Chamber of Commerce The Netherlands & Turkey. As a member you can also actively commit to and be part of the network of the Foundation The Chamber of Commerce The Netherlands & Turkey.

## 2. Who can become member?

Each registered company can become a member of the Foundation The Chamber of Commerce The Netherlands & Turkey.

## 3. Who is the membership intended for?

Each registered company that has interest in the international trade between Turkey and The Netherlands.

## 4. Voting rights

All members may attend to the membership meetings and vote. The articles of association can be found on [kvknederlandturkey.com](http://kvknederlandturkey.com).

## 5. From when to when does a membership year run?

Your membership starts from the date you indicated on the application form, only if membership fee is paid. Membership is valid for one year. Your membership will be automatically extended by one year each year.

## 6. How do you pay your membership fee?

You pay the annual contribution one year ahead. You can pay per bank. Your contribution should be paid before the start of a membership year. Other expenses you make at the foundation, such as costs for our services must be paid within the term that is mentioned on the invoice.

## 7. Can the costs and the terms and conditions change of your membership?

The costs and the terms and conditions of membership can be changed by the board of the Foundation The Chamber of Commerce The Netherlands & Turkey. You will always be informed one month ahead of the start of a new membership year.

## **8. How can you cancel your membership?**

You can cancel your membership by phone or post quoting your membership number. Contact details can be found on our website [www.kvknederlandsturkey.com](http://www.kvknederlandsturkey.com). You will need to cancel your membership one month before the start of a new membership year.

## **9. What happens after you have cancelled your membership?**

You will receive a written confirmation of cancellation. You will remain a member until the end of the current membership year. The remaining of the membership fee for the current membership year will not be repaid. The benefits associated with membership will expire at the end of the current membership year.

## **10. What happens if your payments are late. For example membership fee or others costs you owe the Foundation The Chamber of Commerce The Netherlands & Turkey?**

If it is the case that payments are late, you are immediately in default and we are legally allowed to calculate statutory interest which you need to pay. If you have not paid within fourteen days after you were in default we are entitled to charge you debt collection costs. All benefits associated with membership are cancelled until all debts have been paid. If you are three months behind with payments we will immediately terminate your membership and you will remain liable for payment of all outstanding amounts.

## **11. When can the Foundation The Chamber of Commerce The Netherlands & Turkey terminate your membership?**

After payment defaults described by article 10. If you show aggressive or unreasonable behavior towards our staff or if staff experiences your behavior as threatening. If you do not meet the terms and conditions for membership, including the articles of association.

## **12. What happens after, when we terminate your membership?**

You will receive a written confirmation of termination of your membership. Your membership will be terminated immediately. The remaining membership fee of the current membership year will not be repaid. The remaining outstanding amounts owed to the Foundation The Chamber of Commerce The Netherlands & Turkey will be collected by a debt collection agency.

## **13. How do we deal with your personal information?**

The Foundation The Chamber of Commerce The Netherlands & Turkey stores your personal information when you become a member, when you make use of our services or products and any other contact you make with us. Personal information can further optionally be used according to the way specified on the application form.
